

Liability Release

Warning Waiver and Release of Liability and Agreement to Participate Please read carefully.

In consideration of the acceptance of my entry, I do hereby for myself, my heirs, executors, and administrators, waive, release and forever discharge any and all rights and claims for damages which I may have or may occur to me against the Tournament Directors and their representative officers, agents and representatives, for any and all damages which may be sustained and suffered by me in connection with my association or entry in the athletic meet, or which may occur out of my traveling to, returning from, or participation in such athletic meet and further agree to pay for any legal expenses arising out of any and all legal disagreement, lawsuits, frivolous lawsuits, etc.; and further hereby:

1. Agree that prior to my work out session, I will inspect mats, equipment and facilities which I will be using. If I believe anything is unsafe or beyond my capability, I will immediately advise the staff personally of such condition(s) and refuse to participate:
2. Acknowledge and fully understand that any competition/tournament and Martial Arts is a physical contact sport/activity and that I will be engaging in activities that might result in serious injury, including permanent disability and death and severe social and economic loss due to my own actions, negligence of others, or conditions of the premises or any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
3. Assume all risks involved and accept personal responsibility for the damages following such injury, permanent disability or death.
4. Enter this facility and tournament of my own free will and understand the importance of following all the facility rules and directions given me.
5. Certify that I am in good physical condition and have no disease, injury, or other condition that would impair my performance or physical and mental well being in intense physical activity.
6. Grant permission in case of injury to have a doctor, nurse, athletic trainer or other medical emergency personnel provide me with medical assistance or treatment at my cost for such injury.
7. Release, waive, discharge and covenant not to sue the Alliance of USA Martial Arts (& the Illinois Chapter), ISTA, Inc., McHenry Fitness and Taekwondo, Inc, and Parkland Jr. High School, their/it's owners, management, employees, agents or representatives; all which are hereinafter referred to as releases, from any and all claims, demands, losses, or damages on account of injury, including permanent disability and death or damages to property, caused or alleged to be caused in whole or in part by the negligence of the releases or otherwise.

I/We the parent(s) or legal guardian(s) of this minor participant have instructed or will instruct the minor participating to the above warning and conditions and their ramifications and I/We additionally confirm and agree to all of the above statements, conditions, waivers, and releases and consent to this minors' participation.
